The release/ revalidation of funds is subject to the following conditions:-

1. The execution/ implementation of works/ schemes shall be carried out after observing all codal formalities including Administrative Approval and Technical Sanction from the competent authority and as per BADP guidelines and directions issued by PD&MD / Finance Department from time to time.
2. Proper and transparent e-tendering process is adopted in the execution of works and purchase of material/equipment.
3. It shall be ensured that none of the works being taken-up for execution lie at an aerial distance more than 10 Kms from first habitation of I.B/ LoC.
4. The expenditure against the approved works is restricted to amount released/ revalidated under this order, within AA cost and without increasing the scope of work. No work other than the approved one shall be taken up for execution.
5. While executing schemes/ works, implementing agencies and District Development Commissioners shall ensure that there is no overlapping/ duplication of the schemes/ works with any other programme including languishing projects funded through JKIDFC and no part as a whole of any work already executed under any of the programme is debited to BADP funds released in this order.
6. No funds shall be utilized under any scheme / work / project which is presently under investigation by Crime Branch/ other agencies or enquiry ordered by the Government even if funds are available in this order.
7. Funds released under additionality shall be strictly used only for approved on-going works, details of which shall be shared with this department for onward submission to PD&MD.
8. Inadmissible schemes/ Schemes especially subsidy oriented schemes shall not be taken up as per the instructions of the Ministry of Home Affairs, GOI, Department of Border Management even if funds are available in this order.
9. Photo-graphic evidence indicating pre-execution and post execution shall be kept on record for verification / monitoring purpose.
10. No re-appropriation / diversion of funds from one scheme or programme to another is permissible without the prior permission of the Planning, Development & Monitoring Department.
11. The expenditure under Central Share (Revalidated) shall be booked under proper classification as per BEAMS order issued by Finance Department.
