Subject: Uniformity of rates for hospital investigations in the Health Institutions falling under the administrative control of Director Health Services, Jammu/Kashmir.

Government Order No: 72 HME of 2019
Dated: 17 - 01-2019

WHEREAS, the Department of Health and Medical Education received a bundle of grievances/complaints, that the health institutions of Jammu and Kashmir State are charging differential rates for carrying out various hospital investigations/procedures; and

WHEREAS, the Department issued circular instructions vide No. 02-HME of 2018 dated 09.08.2018 enjoining upon all Health institutions of Jammu and Kashmir to strictly follow the rate structure being in force for SMHS Hospital Srinagar till further orders; and

WHEREAS, keeping in view the gravity of the matter, a committee was constituted vide Govt. Order No. 472-HME of 2018 dated 16.08.2018 for finalization of rate structure required thereof; and

WHEREAS, many follow up meetings and communications were carried out to arrive at a uniform acceptable rate structure; and

WHEREAS, the Department worked out the rate structure for 72 investigations in the first instance, after evaluating the inputs received from various hospitals, especially from JLNM Hospital Srinagar and Govt. Gandhi Nagar Hospital Jammu.

Now, therefore, in the interest of public/patient care, sanction is hereby accorded to the implementation of rate structure (uniform) as per "Annexure A" to this Government Order for various hospital investigations carried out across the State of Jammu and Kashmir.

However, the left out investigations/diagnostic services shall be carried out strictly as per the rate structure being followed in SMHS Hospital Srinagar/SMGS Hospital Jammu, as the case may be, till further orders.


