Subject: Settlement of the period of absence (authorized/unauthorized) in respect of Dr. Meenakshi Devi, Medical Officer.

WHEREAS, Dr. Meenakshi Devi was appointed as Medical Officer in the Health Services Department vide Government Order No. 132-HME of 2014 dated 04-03-2014, submitted her joining report in the Directorate of Health Services Jammu on 19-03-2014. However, simultaneously the aforesaid doctor preferred to undergo PG Course in Anaesthesiology at Government Medical College Jammu;

AND WHEREAS, after the completion of course the said doctor rejoined in Directorate of Health Services, Jammu on 02-08-2016. Subsequently, Dr. Meenakshi was adjusted at DH Doda vide DHSJ Order No: 694-G of 2016 dated 24-08-2016, Thereafter she proceeded on Child Care leave w.e.f. 04-07-2017 to 04-07-2018 which was sanctioned by Directorate of Health Services, Jammu vide Order No.757-G of 2017 dated 08-08-2017. After expiry of leave, the said doctor remained on unauthorized absence upto 19-09-2019.

AND WHEREAS, a final notice was issued by Administrative Department vide No.HME/HRM/179/2017 dated 19-07-2019, Dr. Meenakshi Devi, joined in Directorate of Health Services, Jammu on 20-09-2019;

AND WHEREAS, Directorate of Health Services, Jammu has referred her case to the Administrative Department regarding settlement of period w.e.f 20-03-2014 to 01-06-2016 (period undergone PG Anaeth. at GMC Jammu) and 05-07-2018 to 19-09-2019 (Unauthorized absence) for issuance of appropriate instructions;

AND WHEREAS, the issue with regard to settlement of the intervening period/re-joining was examined in consultation with Director Finance, Health and Medical Education Department (Chairman, Departmental Designated Committee) and the Department while taking considerate view in the matter in the interest of patient care, decided to accept the joining of the doctor notionally from the date she has submitted joining report in Directorate of Health Services, Jammu, i.e. 20-09-2019 and monetarily with immediate effect and to treat the period of undergoing PG in Anesthesiology at GMC Jammu w.e.f 20-03-2014 to 01-06-2016, as extension in joining time which is without financial implications and to treat the period of un-authorized absence w.e.f. 05-07-2018 to 19-09-2019 as Dies Non.

Besides, the concerned doctor shall be warned to remain cautious/careful in future for which disciplinary action shall be initiated against him.

Now therefore, sanction is hereby accorded to:

- i. treat the period of undergoing PG in Anesthesiology at GMC Jammu w.e.f 20-03-2014 to 01-06-2016, in favour of Dr. Meenakshi Devi, Medical Officer as extension in joining time which is without financial implications .
- ii. acceptance of re-joining of the Dr. Meenakshi Devi, Medical Officer **notionally** from the date she has submitted her joining report in Directorate of Health Services, Jammu, i.e. on 20-09-2019 and monetarily with immediate effect.
- iii. treat the period of unauthorized absence w.e.f. 05-07-2018 to 19-09-2019 in favour of Dr. Meenakshi Devi, Medical Officer as "**Dies Non**" subject to the condition that the doctor was not involved in any subversive activities as well as was not employed in any other Government/Private Sector during the said period, for which an affidavit duly authenticated by the 1st Class Judicial Magistrate shall be obtained by the Directorate of Health Services, Jammu from the concerned doctor.

The concerned doctor is **warned** not to leave her place of posting for any occasion in future un-authorizedly failing which disciplinary action shall be initiated against her.
