WHEREAS, Dr. Aman Gupta was appointed as Medical Officer in the Health Services Department vide Government Order No.335-HME of 2010 dated 17-06-2010 and joined on 25-06-2010;

AND WHEREAS, The said doctor had approached Director Health Services, Jammu for permitting him to undergo DNB Nephrology from Global Hospital Hyderabad w.e.f 09-03-2015 to 19-05-2018 and left without the permission/NOC of Administrative Department;

AND WHEREAS, after completion of the DNB Nephrology course, Dr. Aman Gupta joined in the office of Directorate of Health Services, Jammu on 19-05-2018 and requested for its acceptance. In the meanwhile, vide Government Order No.657-HME of 2018 dated 30-11-2018, Dr. Aman Gupta, Medical Officer was deputed to GMC Jammu on inter-cadre deputation basis for a period of two years;

AND WHEREAS, Directorate of Health Services, Jammu sought instructions with regard to settlement of period of absence in respect of Dr. Aman Gupta, Medical Officer w.e.f 09-03-2015 to 19-05-2018;

AND WHEREAS, the issue with regard to settlement of the intervening period was examined in consultation with Director Finance, Health and Medical Education Department (Chairman, Departmental Designated Committee) and the Department while taking considerate view in the matter in the interest of patient care, decided that the period of undergoing DNB Nephrology w.e.f 09-03-2015 to 19-05-2018 in favour of Dr. Aman Gupta, Medical Officer, be treated as leave whatever kind due except study leave and remaining period of short fall be treated as Dies Non. Besides, the concerned doctor shall be **warned** not to leave his place of posting un-authorizedly for any occasion in future;

Now therefore, sanction is hereby accorded to treat the period of undergoing DNB Nephrology w.e.f 09-03-2015 to 19-05-2018 in favour of
