Subject:- Deployment of Officers in Health and Medical Education Department as OSDs for assisting in Corona Virus efforts.

**Government Order No. 309 - (JK)HME of 2020**  
**D A T E D 20 - 03 - 2020**

It is hereby ordered that the services of the officers, who have been deployed in the Health and Medical Education Department as OSDs for assisting in Corona Virus efforts vide Government Order No.404-JK(GAD) of 2020 dated 19.03.2020, shall be utilized in the following manner :-

1. *Mr. Owais Ahmad, IAS shall remain stationed in Srinagar. The arrangements for his office accommodation shall be made by MD, NHM, who shall also provide him the necessary staff required for carrying out the official work. The role of the Officer shall be:-*
  - i. *to co-ordinate all COVID-19 prevention and management activities in Kashmir valley.*
  - ii. *to co-ordinate supervision, screening and surveillance operations.*
  - iii. *supervision of contact tracking.*
  - iv. *supervision of home quarantine measures.*
  - v. *co-ordinating with Divisional Commissioner Kashmir and Deputy Commissioners of Kashmir Division for looking after quarantine facilities and for implementation of various advisories issued/ as may be issued on the subject.*
  - vi. *any other work as may be assigned to him by MD, NHM.*
2. *The other two Officers namely; Mr. Rajeev Kumar Khajuria, KAS, Assistant Commissioner, Survey and Land Records, J&K and Mr. Naser Ali, Assistant Commissioner in the State Taxes Department, Jammu, shall report in the office of MD, NHM at Nagrota, Jammu*

*and shall assist him in the discharge of his duties relating to COVID-19.*




