However, the sanction for purchase of vehicle as well as advance drawl shall be subject to the following conditions:

1. The Chief Accounts Officer, GMC Anantnag / Baramulla / Doda / Rajouri / Kathua shall vouchsafe the availability of funds under Detailed Head: 046 – Purchase of Vehicle.
2. Creation for the post of drivers shall not be involved.
3. The purchase of vehicles is made through State Motor Garages, J&K.
4. The vehicles are utilized for the purpose for which they are meant for.
5. All codal formalities for affecting the purchase shall be adhered to.
6. UC's / Red DC Account of the advance drawls shall be furnished to the concerned quarters including A.G within stipulated time.


