As recommended by the J&K Public Service Commission, sanction is hereby accorded to the temporary appointment of **Suraya Kounser D/O Assad Ullah Dar R/O Sholipora Budgam** as Lecturer under RBA Category in the Department of Ophthalmology in Government Medical College, Jammu, in Pay Level-09; (Rs. 52700-166700), under Jammu & Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O 192 dated 17.06.2020, with immediate effect.

The above candidate shall report to the Principal, Government Medical College, Jammu for joining. In case of failure of the appointee to join within a period of 21 (twenty one) days from the date of issuance of this appointment order, she shall forego her appointment, which shall be deemed to have been cancelled ab-initio without any further notice.

The appointee shall be allowed to join only on production of the following documents/certificates in original:-

1. Date of Birth Certificate.
2. Qualification Certificates.
3. Certificates from the concerned District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been taken by the appointee.
4. Domicile Certificate
5. Health Certificate from the Standing Medical Board.
6. Reserved Category Certificate.
7. Any other documents as required under rules.

The appointment of the above candidate as Lecturer shall further be subject to the following conditions:-

- i) The appointee shall give an undertaking in the shape of an affidavit to the effect that in case any adverse report about her Character and Antecedents is received from the Additional Director General of Police, (CID), J&K, to whom a reference shall be made by the Principal, Government Medical College, Jammu, she shall have no right to claim her appointment, as such, and her appointment shall be deemed to have been cancelled *ab-initio*.



- ii) Verification/genuineness of the qualification certificates/Reserved Category Certificate from the concerned issuing authorities.

The salary of the appointee shall not be drawn and disbursed to her unless the satisfactory reports in respect of (i) and (ii) above are received in her favour.

The appointment of the above candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.

The probation of the appointee and Pay & Allowances during probation shall be regulated in terms of the provisions of the Jammu & Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O 192 dated 17.06.2020 read with J&K Civil Services (Classification, Control and Appeal) Rules 1956.

The interim arrangement, if any, made on contract/deputation or on academic arrangement basis against the above post, shall be deemed to have been terminated forthwith.

The appointment of the above candidate shall be subject to outcome of the writ petition(s), if any, pending before any Competent Court of Law.
