As recommended by the J&K Public Service Commission, sanction is hereby accorded to the temporary appointment of the following candidates as Lecturer in the Department of Physiology in Government Medical College, Jammu, in Pay Level-09; (Rs. 52700-166700), under Jammu & Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O 192 dated 17.06.2020, with immediate effect:-

The above candidates shall report to the Principal, Government Medical College, Jammu for joining. In case of failure of the appointees to join within a period of 21 (twenty one) days from the date of issuance of this appointment order, they shall forego their appointment, which shall be deemed to have been cancelled *ab-initio* without any further notice.

The appointees shall be allowed to join only on production of the following documents/certificates in original:-

1. Date of Birth Certificate.
2. Qualification Certificates.
3. Certificates from the concerned District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been taken by the appointee.
4. Domicile Certificate
5. Health Certificate from the Standing Medical Board.
6. Reserved Category Certificate (Where applicable).
7. Any other documents as required under rules.

The appointment of the above candidates as Lecturer shall further be subject to the following conditions:-

- i) The appointees shall give an undertaking in the shape of an affidavit to the effect that in case any adverse report about their Character and Antecedents is received from the Additional Director General of Police, (CID), J&K, to whom a reference shall be made by the Principal, Government Medical College, Jammu, they shall have no right to claim their appointment, as such, and their appointment shall be deemed to have been cancelled *ab-initio*.

- ii) Verification/genuineness of the qualification certificates/Reserved Category Certificate from the concerned issuing authorities.

The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory reports in respect of (i) and (ii) above are received in their favour.

The appointment of the above candidates shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.

The probation of the appointees and Pay & Allowances during probation shall be regulated in terms of the provisions of the Jammu & Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O 192 dated 17.06.2020 read with J&K Civil Services (Classification, Control and Appeal) Rules 1956.

The inter-se-seniority of the appointee(s) shall be in accordance with the merit secured by them in the selection list prepared by the J&K Public Service Commission.

The interim arrangement, if any, made on contract/deputation or on academic arrangement basis against the above posts, shall be deemed to have been terminated forthwith.

The appointment of the above candidates shall be subject to outcome of the writ petition(s), if any, pending before any Competent Court of Law.
