WHEREAS, Dr. Yuman Kawoosa, was appointed as Medical Officer in the Health Services Department, vide Government Order No. 333-HME of 2018 dated 29-05-2018. However, the said doctor did not join within the stipulated time. Thereafter as per the approval conveyed by the Administrative Department vide communication No. HD/Gaz/Gen/11/2018 dated 26-08-2019, she was allowed to join the Department with immediate effect and was posted at District Hospital Ganderbal;

AND WHEREAS, Dr. Yuman Kawoosa, Medical Officer has tendered her resignation w.e.f 01-09-2020 before the Directorate of Health Services, Kashmir, as she intend to join the academic side;

AND WHEREAS, the Director Health Services, Department Kashmir, vide communication No. Est-3/1-133/965 dated 15-09-2020 forwarded the resignation of Dr. Yuman Kawoosa to the Health and Medical Education Department for acceptance.

AND WHEREAS, the matter has been examined in the Health and Medical Education Department and it has been approved by the Competent Authority to accept the resignation of Dr. Yuman Kawoosa, Medical Officer on her own request.

Now, therefore, in exercise of the powers conferred under Rule 21(1) of the Jammu & Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956, the probation of Dr. Yuman Kawoosa, Medical Officer, Block Ganderbal is terminated and she is discharged from the Jammu & Kashmir Health & Family Welfare (Gazetted) Service on her own request w.e.f. 01-09-2020. As such, her resignation is accordingly accepted.




