In supersession to Government Order No. 833 - JK (HME) of 2020 dated 29.10.2020 issued under endorsement No. HD/Plan/160/2019 dated 29.10.2020, Sanction is hereby accorded to the:

- i) Release of additionality to the tune of Rs 5465.00 lacs (Rupees Fifty Four Crores Sixty Five Lacs Only) under Classification 2211-00-001-00099-2509-009-RRT out of Revenue Budget 2020-21 in favour of Director Finance, Health & Medical Education Department, J&K for payment of Insurance Premium for "Universal Health Coverage - J&K Health Scheme for the financial year 2020-21".
- ii) Advance drawl of Rs 5465.00 lacs (Rupees Fifty Four Crores Sixty Five Lacs Only) by Director Finance, Health and Medical Education Department for its onward credit into the official account of Chief Executive Officer, SHA-Ayushman Bharat, PMJAY, J&K for payment of Insurance Premium for "Universal Health Coverage - J&K Health Scheme for the financial year 2020-21".

The funds shall be utilized subject to the following conditions:

- i) That the Chief Executive Officer and Accounts Officer, Ayushman Bharat (PMJAY), J&K shall vouchsafe the availability of funds under Sub Head 2509- Ayushman Bharat (AB-PMJAY)
- ii) The funds shall be utilized for the original purpose they are meant for, without any deviation.
- iii) All the required codal formalities shall be observed at all levels with due diligence.
- iv) The Red D.C Account / UCs shall be furnished to the concerned quarters within stipulated time.
