Subject: Implementation of judgment dated 01.02.2019 passed by the Hon'ble High Court at Jammu in SWP No. 146 / 2019 titled Dr. Anam Khursheed Vs State of J&K & Others read with judgment dated 23.12.2020 passed in LPA No. 316/2019- titled Union Territory of Jammu and Kashmir & Others Vs Dr. Anam Khursheed.

WHEREAS, the Principal Government Medical College , Jammu vide Order No: 702 of 2019 dated: 08-01-2019 selected Dr. Anam Khursheed, Medical Officer attached with Director Health Services, Jammu as Demonstrator in the discipline of Pathology, Government Medical College, Jammu on a tenure basis for a period of 03 years;

AND WHEREAS, Dr. Anam Khursheed, Medical Officer approached the Hon'ble High Court at Jammu by way of SWP No. 146 / 2019 with the grievance that she has been selected as Demonstrator in the discipline of Pathology, Government Medical College Jammu, but the respondents have not relieved her to join against the said post;

AND WHEREAS, the Hon'ble High Court while disposing of the SWP No. 146/2019 titled Dr. Anam Khursheed Vs State of Jammu and Kashmir & Others on 01-02-2019 passed the following directions: -

"In view of the short controversy, this petition is admitted and disposed of at the threshold by directing respondent Nos. 1 & 2 to relieve the petitioner from the present place of posting to enable her to join on the post of Demonstrator in the Department of Pathology pursuant to Advertisement Notice No. JMC / ES-I / 109 / 1119 dated: 16-10-2018 issued by the respondent No. 4 and respondent No. 4, namely, Principal Government Medical College Jammu, is directed to allow the petitioner to join on the said post at the earliest."

AND WHEREAS, the Health and Medical Education Department filed an LPA bearing no. 316/2019 titled 'Union Territory of Jammu

and Kashmir and others Vs Dr. Anam Khursheed' against the aforesaid writ Court Judgment dated 01.02.2019. The Hon'ble Division Bench of the High Court at Jammu disposed of the said LPA on 23.12.2020 with the following observations /directions:

"Shri H.A. Siddiqui, Sr. AAG, Jammu fairly submits that pursuant to the judgment passed by the writ court, respondents have been permitted to join as Demonstrators and are serving in the Government Medical College, Jammu in their respective department. More than half of the tenure is already over and, therefore, this appeal for all practical purposes has been rendered infructuous. He however, submits that the issue with regard to the condition in the policy that a person who has already remained Demonstrator/Registrar in any of the Department in the SKIMS/Government Medical College is not eligible to be re-engaged/appointed as Demonstrator/Registrar as the case may be.

Having considered the submissions made by Shri H.A. Siddiqui, Additional Advocate General, Jammu and having heard Mr. Rupinder Singh, Learned Counsel for the respondent, we are of the view that this petition by the efflux of time and because of subsequent development is rendered infructuous and the same is accordingly disposed of."

AND WHEREAS, from perusal of the aforesaid judgment dated 23.12.2020 passed by the Hon'ble Division Bench of the High Court at Jammu in LPA No. 316/2019 titled 'Union Territory of Jammu and Kashmir & Others Vs Dr. Anam Khursheed', it transpires that Mr. H.A. Siddiqui, Ld. Sr. AAG, Jammu has made submission before the Hon'ble Court that the respondent (Dr. Anam Khursheed, Medical Officer) has been permitted to join as Demonstrator and is serving at Government Medical College, Jammu in her respective Department and more than half of the tenure is already over and therefore , this appeal for all practical purposes has been rendered infructuous.

AND WHEREAS, in view of the aforesaid submission made by Mr. H.A. Siddiqui, Sr. AAG, Jammu before the Hon'ble Court in the instant case, the Hon'ble Division Bench of High Court at Jammu disposed of the LPA on 23.12.2020 and rendered the same as infructuous.

AND WHEREAS, the Health and Medical Education Department after examining the case of Dr. Anam Khursheed, Medical Officer in pursuance of the aforesaid judgment dated 23.12.2020, has found that the case of the said Medical Officer has become fait-accompali and has decided to implement the writ Court judgment dated 01.02.2019 in toto as the petitioner in pursuance of said writ Court judgment has been allowed by the then Principal Government

Medical College, Jammu, vide communication no. GMCJ/ES-I/PF/1754 dated 05.02.2019, to report to the Head of Department of Pathology in Government Medical College, Jammu as Demonstrator.

Now, therefore, in compliance to the Judgment dated 01.02.2019 passed by the Hon'ble High Court at Jammu in SWP No. 146/2019 titled 'Dr. Anam Khursheed Vs State of J&K & Others' read with judgment dated 23.12.2020 passed in LPA No. 316/2019 titled 'Union Territory of Jammu and Kashmir and others Vs Dr. Anam Khursheed', it is hereby ordered that the petitioner namely Dr. Anam Khursheed, Medical Officer is deemed to have been relieved from the Directorate of Health Services, Jammu to the Government Medical College, Jammu from the date she has joined as Demonstrator in the Department of Pathology in pursuance of the communication No. GMCJ/ES-I/PF/1754 dated 05.02.2019 of the then Principal, Government Medical College, Jammu.
