The advance drawl shall be subject to following further conditions:-

1. The Principal Government Dental College Jammu and Accounts Officer, Government Dental College Jammu shall vouchsafe the availability of funds.
2. The expenditure shall be booked on admissible items only as approved by the competent authority after observing all the required codal formalities.
3. The funds shall be utilized for the purpose they are meant for, without any deviation at all.
4. The funds shall not remain idle in the Bank Account.
5. Red Accounts of the advance drawl shall be furnished to the concerned quarters within stipulated time.
