

The release of funds shall be subject to the following conditions:-

1. The expenditure shall be made strictly according to the classification under which funds have been authorized by the Finance Department.
2. Treasury Officers shall not entertain bills without complete classification under which funds have been authorized by the Finance Department.
3. Drawing and Disbursing Officer (DDO) shall complete all codal formalities before presentation of bills at the Treasury.
4. Treasury Officers shall not allow parking or drawl of funds in the Civil Deposit without the prior concurrence of the Finance Department.
5. The Principal Govt. Medical College, Srinagar/ Jammu shall send status report about the scheme in terms of physical and financial progress made during the current financial year.



6. The Principal Govt. Medical College, Srinagar/ Jammu shall send the Utilization Certificate (UC) of the funds as early as possible and positively before 31-03-2021 to Govt. of India under intimation to this department.
7. All the sanctions/ approvals and clearances shall be in place before drawl of money from the treasury.
8. Director Finance, H&ME Department shall vouchsafe the utilization of funds as per the codal procedure/ Government of India's guidelines.
9. The Principal Govt. Medical College, Srinagar/ Jammu shall incur expenditure strictly as per the guideline of the scheme and the conditions laid down in the sanction letter of the concerned ministry of Government of India.
10. The funds shall be debited as per the following account classification:
