**Subject: Un-authorized absence of doctors – joining thereof.**

**Ref: Letter No. Est/3/1-133/2840 dated 09.02.2021 received from Director, Health Services, Kashmir.**


**WHEREAS**, the Director, Health Services, Kashmir vide Communication No. Est/3/1-133/2646-47 dated 17.12.2019 served notices on the Medical Officers who were on un-authorized absence from their duties. The notice was also published in local daily 'Kashmir Uzma' in its edition dated 20.12.2019, in which an opportunity was given to these doctors to report back for duties;

**WHEREAS**, the Director, Health Services, Kashmir vide communication No. Est/3/1-133/244 dated 22.01.2020 forwarded the list/ details of Medical Officers who were on un-authorized absence from duties to the Administrative Department and to whom the notices were issued vide No. Est/3/1-133/2646-47 dated 17-12-2019;

**AND WHEREAS**, the cases of Medical Officers who were on un-authorized absence were examined in the Department and vide communication No. HME/HRM/33/2014 dated 22.04.2020, last and final opportunity was given to these Medical Officers to report back in Directorate of Health Services, Kashmir within a period of 15 days, failing which, it shall be presumed that the concerned doctors have nothing to say in their defense and proceedings under Rules 25 (2) of the J&K Civil Service leave Rules, 1979 and Article 128 of Jammu & Kashmir Civil Service Regulations, Volume-I shall be initiated against them;

**AND WHEREAS**, the Director, Health Services, Kashmir vide communication No. Est/3/1-133/2840 dated 09.02.2021 has intimated that Dr. Imtiyaz Ahmad Dar, Medical Officer has represented in the Directorate of Health Services Kashmir and requested to allow him to join back in the Department;

**AND WHEREAS**, the case of Dr. Imtiyaz Ahmad Dar, Medical Officer examined in the Department and in the interest of patient care, it has been decided that Dr. Imtiyaz Ahmad Dar, Medical Officer who has submitted the joining report in the Directorate of Health Services, Kashmir in compliance to the notices served upon him, be allowed to rejoin at his place of posting subject to the condition that the said doctor is/was not involved in any subversive activities as well as not employed in any other Government/private sector during the said period, for which an affidavit duly authenticated by the 1<sup>st</sup> Class Judicial Magistrate shall be obtained by the Directorate of Health Services, Kashmir, from



the concerned Medical Officer, besides, the period of his un- authorized absence shall be decided separately.

**NOW, THEREFORE**, sanction is hereby accorded to allow Dr. Imtiyaz Ahmad Dar, Medical Officer to rejoin his duties at DH Bandipora, with prospective effect, subject to the condition that he was not involved in any subversive activities as well as was not employed in any other Government/private sector during the said period, for which an affidavit duly authenticated by the 1<sup>st</sup> Class Judicial Magistrate be obtained by the Directorate of Health Services, Kashmir, from the concerned doctor. However, his period of un-authorized absence shall be decided separately.

It is also ordered that Dr. Imtiyaz Ahmad Dar, Medical Officer is warned not to leave his place of posting for any occasion in future without proper permission from the competent authority, failing which, disciplinary action as warranted under rules, shall be initiated against him exparte.


