Subject: Settlement of period of undergoing higher studies in favour of Dr. Sonali Sharma, Medical Officer.

WHEREAS, Dr. Sonali Sharma, was appointed as Medical Officer in the Health Services Department, vide Government Order No.132-HME of 2014 dated 04-03-2014;

AND WHEREAS, at the time of appointment the aforesaid doctor was undergoing MD Radio-Diagnosis course at Government Medical College, Jammu. After the completion of course the aforesaid doctor reported in Directorate of Health Services, Jammu on 17-06-2014 and was posted at Government Medical College Jammu on Inter cadre deputation vide Government Order No. 302-HME of 2014 dated 13-06-2014;

AND WHEREAS, the said doctor reported in Directorate of Health Services, Jammu on 06-06-2019 and was adjusted at NTPHC Kirpind, Block R.S Pora vide Government Order No. 587-HME of 2019 dated 20-06-2019, but aforesaid doctor did not join there and represented that she had been selected for fellowship in Breast Fellowship in Breast Imaging in the Medanta-the Medicity w.e.f 24-06-2019 and has requested for sanction of study leave for period of one year and left without obtaining permission/NOC of the Administrative Department;

AND WHEREAS, after the completion of course, the said doctor has rejoined on 25-06-2020 in Directorate of Health Services, Jammu;

AND WHEREAS, the Directorate of Health Services, Jammu has forwarded her case regarding re-joining/settlement of higher studies to the Administrative Department for issuance of appropriate instructions;

AND WHEREAS, the issue with regard to settlement of the intervening period was examined in consultation with Director Finance, Health and Medical Education Department (Chairman, Departmental Designated Committee) and the Department while taking considerate view in the matter, in the interest of patient care, decided to accept the rejoining in respect of Dr. Sonali Sharma, Medical Officer, notionally w.e.f 25-06-2020 and monetarily with immediate effect and to treat the period of undergoing Fellowship in Breast Imaging in the Medanta-the Medicity, Gurugram, w.e.f 24-06-2019 to 24-06-2020 in respect of Dr. Sonali Sharma, Medical Officer, as leave whatever kind due except study leave and remaining period of shortfall be treated as Dies-Non and this shall be subject to the condition that the said doctor was not involved in any subversive activities as well as was not employed in Govt/private

sector for which an affidavit authenticated by the 1st Class Judicial Magistrate shall be obtained by the Director, Health Services, Jammu from the concerned doctor.

Now, therefore, sanction is hereby accorded to:-

- i. Accept the rejoining in respect of Dr. Sonali Sharma, Medical Officer, notionally w.e.f 25-06-2020 and monetarily with immediate effect.
- ii. Treat the period of undergoing Fellowship in Breast Imaging in the Medanta-the Medicity, Gurugram, w.e.f 24-06-2019 to 24-06-2020 in respect of Dr. Sonali Sharma, Medical Officer, as leave whatever kind due except study leave and remaining period of shortfall be treated as Dies-Non and this shall be subject to the condition that the said doctor was not involved in any subversive activities as well as was not employed in Govt/private sector for which an affidavit authenticated by the 1st Class Judicial Magistrate shall be obtained by the DHSJ from the concerned doctor.
- iii. The concerned doctor is warned not to leave her place of posting un-authorizedly for any occasion in future, failing which disciplinary action shall be initiated against her without any further notice.

Director, Health Services, Jammu shall fix the responsibility as to who were dealing hands in Directorate who didn't initiate any action against her. The report to be furnished within a month positively.
