Sanction is hereby accorded for:-

- a. Purchase of one unit of vehicle, Tata Winger Ambulance - 35 WB AIS 125 Part - 1 Type - B against the condemned vehicle JK01C - 7746 (TATA - 0407 - Ambulance) in favor of Principal Government Dental College, Srinagar out of the available funds under Capex Budget BE 2020-21 at the tentative cost of Rs 15.25 lacs.
- b. Advance drawl of funds amounting to Rs 15.25 lacs (Rupees Fifteen Lacs Twenty Five Thousand Only) by Principal Government Dental College Srinagar, out of the available funds under Capex Budget 2020-21, classification 4210-01-800-0011-1540-115 - Works below activity Purchase of Ambulance, for effecting the purchase of ambulance.

The purchase of Ambulance and advance drawl shall be subject to following further conditions:-

1. The vehicle is purchased through GeM / State Motor Garages.
2. No post of driver is created.
3. The Principal Government Dental College Jammu and Accounts Officer, Government Dental College Jammu shall vouchsafe the availability of funds.
4. The expenditure shall be booked on admissible items only as approved by the competent authority after observing all the required codal formalities.
5. The funds shall be utilized for the purpose they are meant for, without any deviation at all.
6. The funds shall not remain idle in the Bank Account.
7. Red Accounts of the advance drawl shall be furnished to the concerned quarters within stipulated time.
