As recommended by the Selection Committee, sanction is hereby accorded to the engagement of following candidates to work on faculty posts in the Disciplines as shown against each in Government Medical College, Anantnag on academic arrangement basis in terms of Jammu & Kashmir Medical and Dental Education (Appointment on Academic Arrangement Basis) Rules, 2020, notified vide S.O 364 of 2020 dated 27.11.2020, for a period of three years or till the posts are filled up on regular basis or till they attain the age of 70 years, whichever is the earliest:-

The above candidates shall report to the Principal, Government Medical College, Anantnag, for joining within a period of 21 days from the date of issuance of the order, failing which their engagement shall stand cancelled without any further notice.

The engagement shall be regulated under other terms and conditions as specified in S.O-364 of 2020. The engagement so made on academic arrangement basis shall be extendable upto maximum of six years (one year at a time and subject to good performance and conduct) or till selection is made in accordance with the rules of recruitment governing the respective posts, whichever is earlier and the extension so granted under these rules shall not be beyond a period of six years under any circumstances.

The above arrangement shall be purely on temporary basis for teaching purposes only and shall not confer upon the engagees any special claim/ right for appointment on regular basis against the posts on which they have been engaged, as and when the same are filled under rules.
