Subject: Settlement of period of undergoing Higher studies (DNB Neurology Course) in favour of Dr. Maqsood Ahmad Dar, Medical Officer.

WHEREAS, Dr. Maqsood Ahmad Dar, was appointed as Medical Officer vide Government Order No. 335-HME of 2010 dated 17.06.2010 and the said doctor joined in the Directorate of Health Services, Kashmir on 29.06.2010;

AND WHEREAS, Dr. Maqsood Ahmad Dar, Medical Officer was selected for DNB in Neurology at Max Super Specialty Hospital New Delhi and he had left w.e.f. 12.03.2015 without obtaining permission/NOC of Administrative Department;

AND WHEREAS, Dr. Maqsood Ahmad Dar, Medical Officer after completion of DNB in Neurology from Max Super Specialty Hospital New Delhi has rejoined in Directorate of Health Services, Kashmir on 23.04.2018 and his services were being utilized at District Hospital Kulgam. Thereafter, the concerned doctor was posted at Government Medical College, Anantnag vide Government Order No. 918-HME of 2019 dated 18.10.2019;

AND WHEREAS, Directorate of Health Services, Kashmir has forwarded the case regarding settlement of higher studies to the Administrative Department for issuance of appropriate instructions;

AND WHEREAS, the instant case has been examined in consultation with Director Finance, Health & Medical Education Department (Chairman Departmental Designated Committee), and the department while taking considerate view in the matter, in the interest of patient care, decided to treat the period of undergoing DNB Neurology at Max Super Specialty Hospital New Delhi w.e.f. 12.03.2015 to 22.04.2018, in favour of Dr Maqsood Ahmad Dar, Medical Officer, as leave whatever kind due except study leave and remaining period of shortfall be treated as "Dies-Non", subject to the condition that the said doctor was not involved in any subversive activities as well as was not employed in any Govt./Private sector and no departmental enquiry is pending against him, for which an affidavit authenticated by the 1st Class Judicial Magistrate shall be obtained by the Directorate of Health Services, Kashmir from the concerned doctor. Besides, action taken by Director, Health Services, Kashmir by utilizing his services on rejoining is also confirmed. The concerned doctor shall also be warned not leave his place of posting un-authorizedly for any occasion in future, failing which disciplinary action shall be initiated against him without any further notice. Directorate of Health Services, Kashmir be asked to fix the responsibility who were dealing hands in Directorate and didn't initiate any action against the doctor and report to be furnished within a month positively.

Now, therefore, sanction is hereby accorded to:-

- i. treat the period of undergoing DNB Neurology at Max Super Specialty Hospital New Delhi w.e.f. 12.03.2015 to 22.04.2018, in favour of Dr. Maqsood Ahmad Dar, Medical Officer, as leave whatever kind due except study leave and remaining period of shortfall be treated as "Dies+Non" subject to the condition that the said doctor was not involved in any subversive activities as well as was not employed in any Govt./Private sector and no departmental enquiry is pending against him, for which an affidavit authenticated by the 1st Class Judicial Magistrate shall be obtained by the Directorate of Health Services, Kashmir from the concerned doctor. Besides, action taken by Director, Health Services, Kashmir by utilizing his services on rejoining is also confirmed.

Further the concerned doctor is **warned** not to leave his place of posting for any occasion in future un-authorizedly, for which disciplinary action will be initiated against him without any further notice.

Besides, Directorate of Health Services, Kashmir is asked to fix the responsibility who were dealing hands in Directorate for not initiating any action against him and a report be furnished in this regard within a month positively.
