Subject: Settlement of period of unauthorized absence in favour of Dr. Rouf Hussain Tak, Medical Officer.

WHEREAS, Dr. Rouf Hussain Tak was appointed as Medical Officer in the Health Services, Department vide Government Order No 132-HME of 2014 dated 04-03-2014 and he has submitted joining report in Directorate of Health Services, Kashmir on 11-03-2014. The doctor while posted at DH Anantnag resorted to un-authorized absence from 15-03-2016 to 15-07-2018;

AND WHEREAS, accordingly notice was issued by the Directorate of Health Services, Kashmir to the said doctor vide No: EST/3/1-133/1187-90 dated 06-05-2017 wherein opportunity was given to him to report back to his duties within five days from the date of issuance of notice. The doctor failed to comply the instructions conveyed to him through notice and continued on un-authorized absence. The issue was taken up with the Administrative Department;

AND WHEREAS, the H&ME department issued final notice vide letter No. HME/HRM/179/2017 dated 09-07-2018 to un-authorized doctors wherein fifteen days were given to them to report back in the Directorate Office. The said doctor was also figuring in the notice. The said doctor joined in the Directorate of Health Services, Kashmir on 16-07-2018 and was posted at PHC Kapran Anantnag vide Directorate of Health Services Kashmir office letter No. Est/3/1-133/3831-33 dated 28-07-2018;

AND WHEREAS, thereafter, BMO Verinag vide letter No. Est/BMO/V/198-99 dated 19-06-2019 has reported that the concerned doctor joined on 09-08-2018, thereafter on 10-08-2018 availed station permission for three days after that said doctor did not return back to his duties thereby resorted to un-authorized absence w.e.f 13-08-2018;

AND WHEREAS, the said doctor approached in Directorate of Health Services, Kashmir with an application on 26-06-2019 wherein the said doctor has stated that due to domestic problem he could not continue his duties in Block Verinag. The said doctor has finally requested that he may be allowed to rejoin and has assured that he will never resort to un-authorized absence in future;
