Subject: Settlement of period of undergoing higher studies (Post Graduation) in favour of Dr. Robina Nazir, Medical Officer (now Consultant Anesthesia).

WHEREAS, Dr. Robina Nazir, was appointed as Medical Officer in the Health Services Department, vide Government Order No.702-HME of 2001 dated 04-10-2001, but preferred to undergo Post-Graduation (MD Anth) SKIMS, Soura Srinagar w.e.f 22-10-2001 to 15-05-2005, and left without obtaining permission/NOC of the Administrative Department.

AND WHEREAS, after the completion of said course, the aforesaid doctor rejoined in Directorate of Health Services, Jammu on 16-05-2005;


AND WHEREAS, the aforesaid doctor was appointed Consultant Anesthesia vide Government Order No. 143-HME of 2008 dated 11-01-2008;

AND WHEREAS, the Directorate of Health Services, Jammu has forwarded her case regarding settlement of higher studies to the Administrative Department for issuance of appropriate instructions;

AND WHEREAS, the issue with regard to settlement of the intervening period was examined in consultation with Director Finance, Health and Medical Education Department (Chairman, Departmental Designated Committee) and the Department while taking considerate view in the matter, decided to treat the period of undergoing Post-Graduation (MD Anth) SKIMS, Soura Srinagar w.e.f 22-10-2001 to 15-05-2005 in respect of Dr. Robina Nazir, Medical Officer (now Consultant Anesthesia) as extension in joining time which shall be without financial implications and subject to the condition that the said doctor was not involved in any subversive activities as well as was not employed in any Govt/private sector for which an affidavit authenticated by the 1st Class Judicial Magistrate shall be obtained by the Director, Health Services, Jammu from the concerned doctor.

Now, therefore, sanction is hereby accorded for:-

- i. Treating the period of undergoing Post-Graduation (MD Anth) SKIMS, Soura Srinagar w.e.f 22-10-2001 to 15-05-2005 in respect of Dr. Robina Nazir, Medical Officer (now Consultant Anesthesia) as extension in joining time which shall be without financial implications and subject to the condition



that the said doctor was not involved in any subversive activities as well as was not employed in any Govt/private sector for which an affidavit authenticated by the 1st Class Judicial Magistrate shall be obtained by the Director, Health Services, Jammu from the concerned doctor.

- ii. Further, the concerned doctor is warned not to leave her place of posting un-authorizedly for any occasion in future, failing which disciplinary action shall be initiated against him without any further notice.

Director, Health Services, Jammu shall to fix the responsibility as to who were dealing hands in Directorate who failed to initiate action against her. The report to be furnished within a month positively.


