- (i) To coordinate with CMO and Dy. CMO and ensure smooth implementation of the Scheme in the district.
- (ii) Liaise with the district officials and SHA for addressing operational issues as and when they arise.
- (iii) Liaise with the District Grievance Redressal Cell for resolving all complaints related to AB-PMJAY/SEHAT.
- (iv) To monitor, perform field audits and fraud control functions of all the EHCPs in the district and provide monthly audit reports directly to CEO, SHA.
- (v) Auditing of pre-authorizations and claim processing functions under AB-PMJAY SEHAT.
- (vi) To monitor claims settlement for the Empaneled Health Care Providers.
- (vii) To coordinate and monitor the functioning of insurance company/ISA at District level.
- (viii) To supervise and monitor the functioning of other staff of DIU like District Coordinator and District Information Systems Manager.
- (ix) To per reporting in formats prescribed by the SHA from time to time or as specified in the Scheme Guidelines, at monthly intervals.


