WHEREAS, Mst. Ulfat Gulzar, was appointed as Jr. Grade Nurse in the Health Services Department vide Directorate of Health Services, Kashmir Order No. 151/NG of 2014 dated 06-05-2014 and she submitted her joining report on 07-05-2014;

AND WHEREAS, the said official had been selected for M.Sc Nursing course at SKIMS Soura, Srinagar w.e.f 26-11-2016 and requested for sanction of study leave in her favour. At the that time said official had not completed three years of service which was pre-requisite for sanction study of leave in terms of SRO-274 dated 30-05-2013;

AND WHEREAS, the Directorate of Health Services, Kashmir vide communication No. Est-5/NG-671/2648 dated 11/11/2016 forwarded her case to the Administrative Department for issuance of appropriate necessary instructions on its merits;

AND WHEREAS, the H&ME Department vide communication No. HD/NG/40/2017 dated 29-01-2018 conveyed Director, Health Services, Kashmir to allow the employee to complete her course and the decision with regard to settlement of her period shall be taken after she reports back in the department after completion of her course;

AND WHEREAS, after the completion of course the aforesaid official re-joined in the Office of Medical Superintendent DH Kulgam on 22-10-2018 and presently her services are being utilized at GNM School Kulgam;

AND WHEREAS, the said Directorate forwarded her case regarding settlement of period of higher studies to the Administrative Department for issuance of appropriate necessary instructions;

AND WHEREAS, the issue with regard to settlement of the intervening period was examined in consultation with Director Finance, Health and Medical Education Department (Chairman, Departmental Designated Committee) and the Department while taking considerate view in the matter, decided to treat the period of undergoing MSc Nursing from S.K Institute of Medical Science, SKIMS Soura, Srinagar (Deemed University) w.e.f 26-11-2016 to 21-10-2018 in respect of Mst. Ulfat Gulzar, Jr. Grade Nurse as leave whatever kind due except study leave

and remaining period of shortfall be treated as Dies-Non, subject to the condition that the said official was not involved in any subversive activities as well as was not employed in any Govt./private sector and no departmental enquiry is pending against her for which an affidavit authenticated by the 1st Class Judicial Magistrate shall be obtained by the Directorate of Health Services, Kashmir from the concerned official. Besides, action taken by Medical Superintendent for utilizing her services on rejoining be also confirmed. The concerned official shall be warned not to leave her place of posting un-authorizedly for any occasion in future, failing which disciplinary action shall be initiated against her without any further notice.

Now, therefore, sanction is hereby accorded to:-

- i. Treat the period of undergoing MSc Nursing from S.K Institute of Medical Science, SKIMS Soura, Srinagar (Deemed University) w.e.f 26-11-2016 to 21-10-2018 in respect of Mst. Ulfat Gulzar, Jr. Grade Nurse as leave whatever kind due except study leave and remaining period of shortfall be treated as Dies-Non, subject to the condition that the said official was not involved in any subversive activities as well as was not employed in any Govt./private sector and no departmental enquiry is pending against her for which an affidavit authenticated by the 1st Class Judicial Magistrate shall be obtained by the DHSK from the concerned official. Besides, action taken by Medical Superintendent for utilizing her services on rejoining is also confirmed.

Further, the concerned official is **warned** not to leave her place of posting un-authorizedly for any occasion in future, failing which disciplinary action shall be initiated against her without any further notice.
