**GOVERNMENT ORDER NO. 632-JK(HME) OF 2020

WHEREAS, on the recommendations of the Selection Committee, vide Government Order No. 495-JK(HME) of 2020 dated 23.06.2020, Dr. Muzamil Nazir was engaged as Assistant Professor in the discipline of Community Medicine on Academic Arrangement Basis in Government Medical College, Doda for a period of one year or till the post was to be filled up on regular basis, whichever earlier;

AND WHEREAS, the above Government Order provided that the doctor shall join within a period of 21 days, failing which his engagement shall be deemed to have been cancelled without any further notice;

AND WHEREAS, the Principal, Government Medical College, Doda, vide above quoted reference, has reported that the Dr. Muzamil Nazir did not join within the stipulated time of twenty one (21) days;

AND WHEREAS, the case has been examined in the Department and it has been decided to cancel the engagement of the aforesaid doctor.

Now, therefore, the engagement of Dr. Muzamil Nazir as Assistant Professor in the discipline of Community Medicine on Academic Arrangement Basis in Government Medical College, Doda, accorded vide Government Order No. 495-JK(HME) of 2020 dated 23.06.2020, is hereby cancelled *ab-initio*.
