As recommended by the Selection Committee, sanction is hereby accorded to the engagement of **Dr. Reeta Gupta D/O Mr. Pran Nath R/O Gandhi Nagar, Jammu** as Professor in the discipline of Dermatology in Government Medical College, Kathua, on academic arrangement basis, in terms of the Jammu and Kashmir Medical and Dental Education (Appointment on Academic Arrangement Basis) Rules, 2019, notified vide SRO-24 of 2019 dated 10.01.2019, for a period of three years or till the post is filled up on regular basis or till she attains the age of 70 years, whichever is the earliest.

Dr. Reeta Gupta shall report to the Principal, Government Medical College, Kathua for joining within a period of 21 days from the date of issuance of this order, failing which her engagement as such shall stand cancelled without any further notice.

Dr. Reeta Gupta shall have to execute an agreement with the Government on the prescribed form in terms of SRO-24 of 2019 dated 10.01.2019. Her engagement shall be regulated under other terms and conditions as specified in the said SRO.
