Ex-post facto sanction, in relaxation of the Jammu and Kashmir Civil Services (Medical Attendance-cum-Allowance) Rules, 1990, is accorded to the reimbursement of medical expenses incurred by Mr. Nisar Ahmad Sofi, Nursing Orderly, L.D. Hospital, Srinagar on treatment of his daughter namely Miss Sanaf Nisar, at BLK Hospital, New Delhi, subject to the following conditions:-

- Re-imburement of charges is restricted to items / procedures admissible under rules for the period of hospitalization w.e.f 26.07.2016 to 28.07.2016, 16.08.2016 to 18.08.2016 and 06.09.2016 to 08.09.2016 cost thereof is restricted to the extent of rates applicable to such items / procedures at AIIMS, New Delhi.
- All relevant medical bills / vouchers are verified and countersigned by the competent medical authority of the hospital wherefrom treatment has been undertaken.
- Certificate from the competent authority that the disease is terminal / life consuming.


