As recommended by the Selection Committee, sanction is hereby accorded to the engagement of **Dr. Ghulam Nabi Yattoo S/O Ghulam Ahmad Yattoo R/O Badipora, Chadoora, Budgam** as Professor in the discipline of Medicine in Government Medical College, Baramulla, on academic arrangement basis, in terms of the Jammu and Kashmir Medical and Dental Education (Appointment on Academic Arrangement Basis) Rules, 2019, notified vide SRO-24 of 2019 dated 10.01.2019, for a period of three years or till the post is filled up on regular basis or till he attains the age 70 years, whichever is the earliest.

The arrangement shall be purely on temporary basis for teaching purposes only and shall not confer upon him any special claim/ right for appointment against the post on regular basis as and when the same is made under rules.

**Dr. Ghulam Nabi Yattoo** shall have to execute an agreement with the Government on the prescribed form in terms of SRO-24 of 2019 dated 10.01.2019. His engagement shall be regulated under other terms and conditions as specified in the said SRO.


