WHEREAS, Dr. Imtiyaz Ahmad Khan was appointed as Medical Officer in Health Department vide Government Order No:132-HME of 2014 dated 04-03-2014;

AND WHEREAS, Dr. Imtiyaz Ahmad Khan, Medical Officer, while posted at District Hospital Pulwama was selected as Registrar in the Department of Radiology at GMC Srinagar in the year 2015 and after completion of Registrarship he was relieved from GMC Srinagar w.e.f 26-03-2018, pursuant to which he submitted his joining report in DHSK on 29-03-2018;

AND WHEREAS, simultaneously, Dr. Imtiyaz Ahmad Khan had been selected for Fellowship in ILBS New Delhi and he joined the same without the approval of the Competent Authority. Thereafter, the said doctor joined as Sr. Resident at AIIMS w.e.f 19-06-2018 till 18-12-2018 and in the meanwhile he was selected for Fellowship Thoracic Radiology in AIIMS which he joined on 01-01-2019 and completed on 31-12-2019;

AND WHEREAS, Dr. Imtiyaz Ahmad Khan left his station unauthorizedly w.e.f 30-03-2018 without approval of the competent authority for undergoing various courses and the said doctor tendered his resignation w.e.f. 17-09-2020 requesting for its acceptance;

AND WHEREAS, Dr. Imtiyaz Ahmad Khan, Medical Officer is requesting acceptance of his resignation w.e.f. 17-09-2020, whileas, he was unauthorizedly absent from his duties since 30-03-2018;

Now, in view of above and in exercise of the powers conferred under Art.200 of the J&K CSRs, Vol-I, the resignation of Dr. Imtiyaz Ahmad Khan, Medical Officer, Directorate of Health Services, Kashmir is hereby accepted and his services are terminated and he is discharged from the J&K Health & Family Welfare

(Gazetted) Service on his own request w.e.f. 30-03-2018 as he was physically absconding from the said date.
