Subject: Settlement of period of undergoing higher studies (DNB in Cardiology) in favour of Dr. Pandit Tafiq Johan, Medical Officer.

WHEREAS, Dr. Pandit Tafiq Johan, was appointed as Medical Officer in the Health Services Department vide Government Order No 335-HME of 2010 dated 17-06-2010 and he submitted joining report in Directorate of Health Services, Kashmir on 23-06-2010;


AND WHEREAS, the said doctor while working as Registrar in Government Medical College Srinagar approached to the office of Directorate of Health Services, Kashmir with an application, stating therein that he has been selected for DNB Super Specialty Course (Cardiology) through National Board of Examination at Fortis Hospital Shalimar Bagh New Delhi w.e.f, 13-03-2015 and has accordingly requested that he may be allowed to join the said course;

AND WHEREAS, the H&ME Department vide communication No. HD(Gaz)Gen-48/2015 dated 21-05-2015 has conveyed NOC in favour of Dr. Pandit Tafiq Johan, Medical Officer for undergoing DNB Super specialty course (Cardiology), subject to the condition that the period of study shall be decided separately under rules;

AND WHEREAS, after the completion of course, the aforesaid doctor re-joined in Directorate of Health Services, Kashmir on 23-03-2018 and was posted at CHC Rajpora by the Directorate of Health Services, Kashmir. The said doctor is presently posted at DH Pulwama and is drawing salary from there;

AND WHEREAS, the said Directorate forwarded his case regarding settlement of period of higher studies to the Administrative Department for issuance of appropriate necessary instructions;

AND WHEREAS, the issue with regard to settlement of the intervening period was examined in consultation with Director Finance, Health and Medical Education Department (Chairman, Departmental Designated Committee) and the Department while taking considerate view in the matter, decided to treat the period of undergoing higher studies (DNB in



Cardiology) at Fortis Hospital Shalimar Bagh New Delhi, w.e.f 13-03-2015 to 22-03-2018 in respect of Dr. Pandit Tafiq Johan, Medical Officer as leave whatever kind due except study leave and remaining period of shortfall be treated as Dies Non, subject to the condition that the said doctor was not involved in any subversive activities as well as was not employed in any Govt./private sector and no departmental enquiry is pending against him, for which an affidavit duly authenticated by the Ist Class Judicial Magistrate shall be obtained by the Director, Health Services, Kashmir from the concerned doctor. The concerned doctor shall be warned not to leave his place of posting un-authorizedly for any occasion in future, failing which disciplinary action shall be initiated against him without any further notice.

Now, therefore, sanction is hereby accorded to:-

- i. Treat the period of undergoing higher studies (DNB in Cardiology) at Fortis Hospital Shalimar Bagh New Delhi, w.e.f 13-03-2015 to 22-03-2018 in respect of Dr. Pandit Tafiq Johan, Medical Officer as leave whatever kind due except study leave and remaining period of shortfall be treated as Dies Non, subject to the condition that the said doctor was not involved in any subversive activities as well as was not employed in any Govt./private sector and no departmental enquiry is pending against him, for which an affidavit duly authenticated by the Ist Class Judicial Magistrate shall be obtained by the Director, Health Services, Kashmir from the concerned doctor.

Further, the concerned doctor is **warned** not to leave his place of posting un-authorizedly for any occasion in future, failing which disciplinary action shall be initiated against him without any further notice.


