Subject: Settlement of period of undergoing higher studies in favour of Dr. Deepika Dewan, Medical Officer.

Ref: No.ES-3/5819/3339 dated 20-11-2019 from Directorate of Health of Services, Jammu.

WHEREAS, Dr. Deepika Dewan was appointed as Medical Officer in the Health Services Department, vide Government Order No.592-HME of 2011 dated 28-10-2011. At the time of appointment the aforesaid doctor preferred to undergo PG in Community Medicine at Government Medical College Jammu w.e.f 14-11-2011 to 31-05-2013;

AND WHEREAS, after the completion of course, the aforesaid doctor has rejoined on 01-06-2013 in Directorate of Health Services, Jammu and was posted at Govt Hospital Sarwal Jammu. The aforesaid doctor is presently posted at Anti Rabies Unit GMC Jammu;

AND WHEREAS, the Directorate of Health Services, Jammu has forwarded her case regarding settlement of higher studies to the Administrative Department for issuance of appropriate instructions;

AND WHEREAS, accordingly, with the prior consent of Director, Finance, H&ME (Chairman, Departmental Designated Committee), the proposal for settlement of absence period was submitted to the authorities. However, the case file was referred to Financial Commissioner Finance Department for considered views. Finance Department vide their U.O No. No.A/46/2017/Dies-Non-359 dated 13-05-2020 returned the file with the following opinion:-

*"Returned: The department is informed that in the instant case the doctor has joined the service on 01-06-2013 her service shall be begin from the date i.e 01-06-2013, when she has taken the charge of office to which she is first appointed."*

AND WHEREAS, the issue with regard to settlement of the intervening period was examined in consultation with Director Finance, Health and Medical Education Department (Chairman, Departmental Designated Committee) and the Department while taking considerate view in the matter, decided that the period of undergoing higher studies (PG in Community Medicine) at Government Medical College Jammu, w.e.f 14-11-2011 to 31-05-2013 in respect of Dr. Deepika Dewan, Medical Officer, be treated as extension in joining time which is without financial implications and her service shall begin from the date 01-06-2013, when she has taken the charge of office to which she was first appointed, subject to the condition that the said doctor was not involved in any subversive activities as well as was not employed in any Govt/private sector for which an affidavit duly authenticated by the 1st Class Judicial Magistrate shall be obtained by the DHSJ from the concerned doctor.

Now, therefore, sanction is hereby accorded to:-

- i. Treat the period of undergoing higher studies (PG in Community Medicine) at Government Medical College Jammu, w.e.f 14-11-2011 to 31-05-2013 in respect of Dr. Deepika Dewan, Medical Officer, as extension in joining time which shall be without

- financial implications and her service shall begin from the date 01-06-2013, when she has taken the charge of office to which she was first appointed, subject to the condition that the said doctor was not involved in any subversive activities as well as was not employed in any Govt/private sector for which an affidavit duly authenticated by the 1st Class Judicial Magistrate shall be obtained by the DHSJ from the concerned doctor.
- ii. The concerned doctor is warned not to leave her place of posting for any occasion in future un-authorizedly, for which disciplinary action shall be initiated against him without any further notice.

Director, Health Services, Jammu is asked to fix the responsibility as to who were dealing hands in Directorate who didn't initiate any action against her. The report to be furnished within a month positively.
