Sanction is hereby accorded to the temporary appointment of Mr. Aamir Hussain Ganie S/o Late Farooq Ahmad Ganie (Ex-Class-IV) R/o Aung Nanil, Tehsil Mattan, District Anantnag, as Class-IV (Orderly), in the Pay Level of SL-1 (14800-47100) in the Directorate of Health Services Department, Kashmir in relaxation of prescribed qualification in terms of Rule-7 of SRO-43 of 1994.

The appointee shall report to the Director, Health Services Department, Kashmir within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/ certificates (in original) to be verified by the concerned Head of the Department subsequently:-

- I. Academic Qualification Certificate.
- II. Date of Birth Certificate.
- III. Domicile Certificate.
- Health Certificate from the concerned CMO of District.
- V. Dependent Certificate issued by the Assistant Commissioner, Revenue.
- VI. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.
- VII. All other relevant documents as are required under SRO-43 of 1994 and other Acts/Rules presently in vogue on the subject.

The appointment of the appointee, shall further be subject to the following conditions:-

- a) That he shall give an undertaking in the shape of an affidavit to the effect that:-
 - (i) In case adverse report about his Character and Antecedents is received from the Inspector General of Police, (CID) J&K, to whom a reference shall be made by the Director, Health Services, Kashmir, he shall have no right to claim his appointment as Class-IV (Orderly) in the Directorate of Health Services, Kashmir and his appointment, as such, shall be deemed to have been cancelled ab-initio;

- (ii) If, on verification, genuineness of the qualification certificates from the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as Class-IV (Orderly) shall also be deemed to have been cancelled ab-inition and the legal action as warranted under rules shall be initiated against him.
- b) The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of (i) and (ii) above are received in his favour.
- c) The appointee shall be initially on probation for a period of two years and his probation shall be governed by the Jammu & Kashmir Probation (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O 192 dated 17.06.2020.
- d) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009 issued by the Finance Department.
- e) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order, he shall forego his right to appointment, which shall be deemed to have been cancelled abinitio, without any further notice.
