
**Government Order No: 587 -JK(HME) of 2020**

WHEREAS, Dr. Payal Gupta, was appointed as Medical Officer in the Health Services Department vide Government Order No. 464-HME of 2005 dated 01-08-2005. However, at that time, the said doctor was pursuing Post Graduation (MS Ophtho.) from GMC Jammu and continued with the same. The said doctor after completion of her course reported to Directorate of Health Services, Jammu on 13-06-2008;

AND WHEREAS, Directorate of Health Services, Jammu has submitted the case of the doctor for instructions of the administrative department with regard to settlement of period in respect of the aforesaid doctor;

AND WHEREAS, the instant case has been examined in consultation with Director Finance, Health & Medical Education Department (Chairman, Departmental Designated Committee), and the department while taking a considerate view in the matter, in the interest of patient care, decided to treat the period of undergoing Post Graduation (Ophtho.) at GMC Jammu w.e.f 03-08-2005 to 12-06-2008, in respect of Dr. Payal Gupta, Medical Officer, as extension in joining time which is without any financial implication. The concerned doctor shall be warned not to leave her place of posting unauthorizedly for any occasion in future for which disciplinary action shall be initiated against her without any notice. Besides, Directorate of Health Services, Jammu be asked to fix the responsibility who were dealing hands in Directorate and didn't initiate any action against her and report to be furnished within a month.

Now, therefore, sanction is hereby accorded to treat the period of undergoing Post Graduation (Ophtho.) at GMC Jammu w.e.f 03-08-2005 to 12-06-2008, in favour of Dr. Payal Gupta, Medical Officer, as extension in joining time which is without any financial implication. The concerned doctor is **warned** not to leave her place of posting unauthorizedly for any occasion in future for which disciplinary action shall be initiated against her without any notice.



Besides, Directorate of Health Services, Jammu is requested to fix the responsibility who were dealing hands in the Directorate and didn't initiate any action against him and report be furnished within a month.
