Subject: Termination of probation and discharge from the J&K Health & Family Welfare (Gazetted) Service.

WHEREAS, on the recommendations of the J&K PSC, sanction vide Government Order No. 333-HME of 2018 dated 29-05-2018, was accorded to the temporary appointment/posting of Dr. Shakeel Ahmad Rather as Medical Officer, in the pay scale of Rs. 9300-34800 with Grade pay of Rs. 5400/- (Pre Revised) in the Jammu and Kashmir Health and Family Welfare (Gazetted) Service;


AND WHEREAS, at the time of his appointment, Dr. Shakeel Ahmad Rather was undergoing PG in the Department of Radio-Diagnosis at GMC Jammu and applied for extension in joining time;

AND WHEREAS, vide Government Order No.630-HME of 2018 dated 20-11-2018, among others, extension in joining time was also granted in favour of Dr. Shakeel Ahmad Rather (appointee) for undergoing PG in the Department of Radio-Diagnosis at GMC Jammu upto 07/2019;

AND WHEREAS, after completion of PG Course, the said doctor joined in the Directorate of Health Services, Kashmir on 06-07-2019 and vide Government Order No. 58-JK(HME) of 2019 dated 13-12-2019, Dr. Shakeel Ahmad Rather, Medical Officer was posted at District Hospital, Kulgam;

AND WHEREAS, Dr. Shakeel Ahmad Rather failed to join at his place of posting thereby resorting to un-authorized absence as reported by Director Health Services, Kashmir vide communication No. Est/3/1-133/886 dated 17-03-2020 and requested for taking further necessary action against the doctor as warranted under rules.

Now therefore, in exercise of the powers conferred under Rule 21(1)(b) of the J&K Civil Services (Classification, Control and Appeal) Rules, 1956, the probation of following Medical Officer appointed vide Government Order No: 333-HME of 2018 dated 29-05-2018, who had submitted his joining report after seeking extension in joining time, but is not physically continuing at his respective place of posting as on date, is hereby terminated and is



discharged from the J&K Health & Family Welfare (Gazetted) Service forthwith:-


