Subject:- Acceptance of resignation of Dr. Nitin Mahajan S/O Kapil Mahajan R/O Opp. Micro Wave Tower Patel Nagar, Kathua , Medical Officer, ISM Department.

**Government Order No:-261-JK(HME) of 2021**

**Dated:- 01-04-2021**

**WHEREAS,** Sh. Nitin Mahajan S/O Kapil Mahajan R/O Opp. Micro Wave Tower Patel Nagar, Kathua was appointed as Medical Officer Ayurvedic, vide Government order No. 585-HME of 2009 dated 30.12.2009;

**AND WHEREAS,** on the basis of the Hon'ble Court directions in SWP No. 2152/2010 & CMP No. 3439/2-2- and CMP No. 3043/2010, Dr. Nitin Mahajan, Medical Officer, ISM left for post graduation course, at Jammu Institute of Ayurveda & Research, Jammu on 27.10.2010, without permission from the Competent Authority;

**AND WHEREAS** , after completion of post graduation from Jammu Institute of Ayurveda & Research, Jammu, Dr. Nitin Mahajan submitted his joining report on 08.08.2011, to the Director Indian Systems of Medicine, J&K, Jammu which he subsequently forwarded to the Administrative Department for further necessary action ;

**AND WHEREAS,** the Administrative Department vide its letter No. HD/ISM/218/2011 dated 31.07.2012, accepted the joining report of Dr. Nitin Mahajan, Medical Officer, with the condition that the Medical Officer will be treated into service from the date he has physically joined after completion of higher studies viz. 08.08.2011;



**AND WHEREAS**, the officer, however subsequently submitted his resignation to the Assistant District Medical Officer, Kathua on 12.10.2013 for its proper acceptance, on the grounds that he is not in a position to continue his services in wake of some personal problems;

**AND WHEREAS**, the Assistant District Medical Officer, Kathua, vide his letter No. ADMO/ISM/K//454 dated 12.10.2013, forwarded the resignation of Dr. Nitin Mahajan, Medical Officer to the Deputy Director, Indian Systems of Medicine, J&K, Jammu for further necessary action;

**AND WHEREAS**, Sh. Nitin Mahajan later submitted his joining report on 07.06.2018 to the Assistant District Medical Office Kathua, on the grounds that his resignation has not been technically accepted by the Government.

**AND WHEREAS**, Assistant District Medical Officer, Kathua vide his letter No. ADMO/ISM/K/452 dated 07.06.2018, forwarded the copy of the representation of Dr. Nitin Mahajan to the Deputy Director, Indian Systems of Medicine, Jammu for further necessary action, which was subsequently forwarded to the Administrative Department by the Director Indian Systems of Medicines, J&K, Jammu vide letter No. DISM/Estt/10645 dated 15.01.2020, for consideration with further details that as per available records in the Directorate of Indian Systems of Medicines, neither any resignation has been received by the Directorate nor anything which would substantiate that resignation has been forwarded to the Administrative Department for acceptance, is available.

**AND WHEREAS**, the matter was examined in the Health and Medical Education Department and was referred to the General





General Administration Department vide their UO dated 03.03.2021, inter allia, advised the Health and Medical Education Department, to accept the resignation of the Dr. Nitin Mahajan, Medical Officer ISM w.e.f. 12.10.2013.

Now, therefore, it is hereby ordered that resignation tendered by Dr. Nitin Mahajan, Medical Officer (Ayurvedic), Government Ayurvedic Dispensary, Mechhedhi, Distt. Kathua, Jammu, vide his application dated 12.10.2013, is hereby accepted from the date he has submitted it viz. 12.10.2013.




