**Subject: Fixation of Seniority of Medical Officers of Health and Family Welfare Department (Ladakh).**


**WHEREAS**, the Final Seniority List of Medical Officers of the Health & Family Welfare (Gazetted) Service was issued vide Government Order No. 477-HME of 2017 dated 06.09.2017;

**AND WHEREAS**, subsequent to the issuance of the said seniority list, some doctors have retired on superannuation, terminated or adjusted in other services/cadre and some have been appointed afresh in the department;

**AND WHEREAS**, with the re-organization of the State of Jammu & Kashmir into two Union Territories of Ladakh and Jammu & Kashmir, vide SRO-695 dated 25-10-2019, the cadre of the Jammu & Kashmir, Health & Family Welfare (Gazetted) Service upon exclusion of posts of Union Territory of Ladakh was created. The bifurcation of the posts among the Union Territories of Jammu & Kashmir and Ladakh was notified vide SRO-697 dated 25.10.2019. Among others 174 posts of Medical Officers (Allopathic) were allotted to the Union Territory of Ladakh;

**AND WHEREAS**, vide Government Order No. 37-JK(HME) of 2020 dated 09.01.2020, a Tentative Seniority List of Medical Officers of Health and Family Welfare Department as it stood on 01.01.2020 was notified by the Department and it was ordered that any Medical Officer aggrieved with the position assigned to him/her, can make an appeal/file objections, if he/she so desires, under the relevant provisions of J&K Civil Services (Classification, Control and Appeal) Rules, 1956 within a period of 21 days in their respective Directorates of Health Services;

**AND WHEREAS**, a number of Medical Officers filed objections/represented to the Administrative Department and the Directorates of Health Services, Jammu/Kashmir with documentary proof in support of their claim for considering their names for inclusion in the seniority list, correction in date of birth, date of appointment, inclusion of higher qualification/category etc:



**AND WHEREAS,** all the representations were examined and corrections wherever necessary were made in the tentative seniority list. No representation/objection was filed by any Medical Officers working in the Union Territory of Ladakh against the said tentative seniority list. Accordingly, final Seniority List of Medical Officers of Health & Family Welfare Department was issued vide Government Order No.849-JK (HME) of 2020 dated 11.11.2020;

**AND WHEREAS,** it came to the notice of the Department that Medical Officers posted in Union Territory of Ladakh have represented before the higher authorities that their names have not been included in the final seniority list issued vide Government Order No.849-JK (HME) of 2020 dated 11.11.2020;

**NOW, THEREFORE,** the Tentative Seniority list of Medical Officers of the Health & Family Welfare (Gazetted) Service (Ladakh), forming **Annexure "A"** to this Order, is issued for information of all the concerned. Any Medical Officer who is aggrieved with the position assigned to him/her can make an appeal/file objections if he/she so desires, under the relevant provisions of J&K Civil Service (Classification, Control and Appeal) Rules, 1956, within a period of 21 days in the Directorate of Health Services Ladakh/Kashmir. The date of birth recorded against the names in the seniority list shall not be taken as authentic and shall be subject to verification of service record.

**The Tentative Seniority list shall be available on the official website of Health & Medical Education Department 'www.jkhealth.org'. The list shall also be available in the Directorate of Health Services, Jammu/Kashmir/Ladakh.**


