WHEREAS, Dr. Zoya Chowdhary was appointed as Dental Surgeon in the Health Services Department vide Government Order No.149-HME of 2012 dated 28.02.2012 and joined in the Directorate of Health Services, Jammu on 29.02.2012;

AND WHEREAS, the aforesaid doctor was granted NOC to undergo MDS Course in Periodontic in Teerthanker Mahaveer Dental College, Moradabad vide H&ME department's letter No. HD/Gaz/Gen/62/2014 dated 29.05.2014 with the condition that her period of study leave shall be decided in terms of SRO-274 of 2013 dated 30.05.2013;

AND WHEREAS, the said doctor is presently working in Govt. Dental College, Jammu on inter cadre deputation basis vide Government Order No. 432-HME of 2017 dated 14.08.2017;

AND WHEREAS, Directorate of Health Services, Jammu has forwarded the case of higher studies w.e.f 14.06.2014 to 13.06.2017 in favour of the aforesaid doctor to Administrative Department for further instructions;

AND WHEREAS, the instant case has been examined in consultation with Director Finance, Health & Medical Education Department (Chairman Departmental Designated Committee), and the Department while taking considerate view in the matter, in the interest of patient care, decided to treat the period of undergoing MDS course in Periodontic in Teerthanker Mahaveer, Dental College, Moradabad w.e.f 14.06.2014 to 13.06.2017 in respect of Dr. Zoya Choudhary, Dental Surgeon as leave whatever kind due except study leave and remaining period of short fall be treated as Dies-Non subject to the condition that the said doctor was not involved in any subversive activities as well as she was not employed in any Government/Private sector and no departmental enquiry is pending against her, for which an affidavit authenticated by 1st Class Judicial Magistrate shall be obtained by the Directorate of Health Services, Jammu from the concerned doctor. Besides, the concerned doctor shall be warned not to leave her place of

posting for any occasion in future un-authorizedly, for which disciplinary action shall be initiated against her without any further notice.

Now therefore, sanction is hereby accorded to treat the period of undergoing MDS Course in Periodontic in Teerthanker Mahaveer, Dental College, Moradabad w.e.f 14.06.2014 to 13.06.2017 in respect of Dr. Zoya Choudhary, Dental Surgeon as leave whatever kind due except study leave and remaining period of short fall be treated as Dies Non subject to the condition that the said doctor was not involved in any subversive activities as well as she was not employed in any Government/Private sector and no departmental enquiry is pending against her, for which an affidavit authenticated by 1st Class Judicial Magistrate shall be obtained by the Directorate of Health Services, Jammu from the concerned doctor.

Besides, the concerned doctor is **warned** not to leave her place of posting for any occasion in future un-authorizedly, for which disciplinary action shall be initiated against her without any further notice.
