Subject: Settlement of period of higher studies (DNB Super Speciality Course in Minimal Access Surgery) in favour of Dr. Shahid Anjum Awan, Consultant Surgeon.

WHEREAS, Dr. Shahid Anjum Awan, was appointed as Medical Officer in the Health Services, Department vide Government Order No. 335-HME of 2010 dated 17-06-2010 and he has submitted joining report in Director, Health Services, Jammu on 23-06-2010;

AND WHEREAS, the aforesaid doctor had been selected for DNB Super Specialty course in Minimal Access Surgery in Madras Medical College and Rajiv Gandhi Government General Hospital EVR Periyar Road Chennai, w.e.f 09-04-2018. The aforesaid doctor left for the said course without obtaining prior permission/NOC of the Administration Department;

AND WHEREAS, while undergoing the said course, the aforesaid doctor was appointed as Consultant Surgeon vide Government Order No. 261-HME of 2019 dated 28-02-2019 and he has joined as Consultant Surgeon at SDH Mendhar on 20-03-2019 and has requested to allow him to complete the remaining period of Fellowship Madras Medical College, Chennai. After the completion of course, the said doctor has rejoined in Directorate of Health Services, Jammu on 23-07-2020;

AND WHEREAS, Directorate of Health Services, Jammu has forwarded his case regarding rejoining/settlement of period of higher studies to the Administrative Department for instructions and orders;

AND WHEREAS, the instant case has been examined in consultation with Director Finance, Health & Medical Education Department (Chairman Departmental Designated Committee), and the Department while taking considerate view in the matter, in the interest of patient care, decided to accept the re-joining of Dr. Shahid Anjum Awan, as Consultant Surgeon, notionally i.e. 23.07.2020 and monetarily with immediate effect and treat the period of undergoing of higher studies (DNB Super Specialty course in Minimal Access Surgery) in Madras Medical College and Rajiv Gandhi Government General Hospital EVR Periyar Road Chennai, w.e.f. 09-04-2018 to 19-03-2019 in favour of Dr. Shahid Anjum Awan, Medical Officer as leave whatever kind due except study leave and remaining period of shortfall be treated as Dies Non . Further, the period of undergoing higher studies (DNB Super Specialty course in Minimal Access Surgery) in Madras Medical College and Rajiv Gandhi Government General Hospital EVR Periyar Road Chennai, w.e.f 21-03-2019 to 22-07-2020 in favour of Dr. Shahid Anjum Awan shall be treated as extension of joining time which is without any financial implication, subject to the condition that the said doctor

was not involved in any subversive activities as well as was not employed in any Govt./Private sector and no departmental enquiry is pending against him, for which an affidavit authenticated by the 1st Class Judicial Magistrate shall be obtained by the Director, Health Services, Jammu from the concerned doctor. Besides, the concerned doctor shall be warned not to leave his place of posting for any occasion in future un-authorizedly, for which disciplinary action shall be initiated against him without any further notice. Moreso, Directorate of Health Services, Jammu be asked to fix responsibility who were dealing hands in Directorate for not initiating any action against unauthorized absentee and a report in this regard be furnished within a month positively.

Now therefore, sanction is hereby accorded to:-

- i. accept the re-joining of Dr. Shahid Anjum Awan, as Consultant Surgeon, notionally i.e. 23-07-2020 and monetarily with immediate effect.
- ii. treat the period of undergoing of higher studies (DNB Super Specialty course in Minimal Access Surgery) in Madras Medical College and Rajiv Gandhi Government General Hospital EVR Periyar Road Chennai, w.e.f 09-04-2018 to 19-03-2019 in favour of Dr. Shahid Anjum Awan, Medical Officer as leave whatever kind due except study leave and remaining period of shortfall be treated as Dies Non.
- iii. treat the period of undergoing of higher studies (DNB Super Specialty course in Minimal Access Surgery) in Madras Medical College and Rajiv Gandhi Government General Hospital EVR Periyar Road Chennai, w.e.f 21-03-2019 to 22-07-2020 in favour of Dr. Shahid Anjum Awan as extension of joining time which is without any financial implication.

The aforesaid decisions (i, ii & iii) shall be subject to the condition that the said doctor was not involved in any subversive activities as well as was not employed in any Govt./Private sector and no departmental enquiry is pending against him, for which an affidavit authenticated by the 1st Class Judicial Magistrate shall be obtained by the Director, Health Services, Jammu from the concerned doctor.

Besides, the concerned doctor is **warned** not to leave his place of posting for any occasion in future un-authorizedly, for which disciplinary action shall be initiated against him without any further notice.

Further, Directorate of Health Services, Jammu is asked to fix the responsibility who were dealing hands in Directorate for not initiating any action against her and a report be furnished in this regard within a month positively.
